QUALITY

- **Consider the organization's context:** Understand internal and external factors that can influence ACTUATECH's strategic objectives, Quality Management System, products, services, investments, and stakeholders.
- **Understand the needs and expectations of stakeholders:** Analyze and respond to their present and future needs, propose products, solutions, and services that not only meet requirements but also exceed market expectations, reinforcing our ability to maintain and promote new investments, stimulating the vitality and continuous development of our organization, and enhancing trust in the ACTUATECH brand and our competitiveness in the market.
- Establish unity of purpose and direction for the organization by **involving Process Managers and all collaborators:** Create and maintain an internal environment that fully engages staff in pursuing the organization's objectives.

- **Improve flexibility and responsiveness to market changes or stakeholder expectations:** Select suppliers sensitive to quality, sustainability, and collaboration in service as primary values.

ENVIRONMENT

To achieve this, we manage processes to ensure environmental respect and protection, optimal use of natural resources, and raw materials.
